

Plan of Action Prohibition of Ragging for the year 2019-20

- Committee resolves that to conduct an awareness programme.
- The committee resolves that to display the mobile numbers of the committee members along with names in all notice boards.
- Resolves to give instructions about the directives of the government and courts and the punishment that are prescribed for an offence of ragging to all the students are issued.
- Committee resolves that frequent visits should be done by the members at floating points of the institution i.e. Canteen, Library, Entrance gate, notice boards, corridors, etc.
- To install the "COMPLIANT BOXES" in each floor, so that students can complain against the offenders.
- Resolves the counsel the senior students as well as freshers.
- To make understanding in the prescribed format as given the university from all the students including freshers.
- Surprise visits should be made by the committee members at floating points i.e. Canteen, Library, Hostels, Notice boards etc.
- Committee resolves to meet once in a month to discuss any implementation to eliminate the ragging in future.
- The committee resolves that to arrange a program by the local police authorities for the seniors and freshers in this regard.
- Should bring any offence occurred to the kind notice of the Chairman of the committee and Convener of the committee without any delay.
